Welcome and Thank You for your interest in supporting Feeding the Homeless Project, Inc.!

For over ten years a small group of volunteers have regularly met on a Saturday morning each month to bring mobile meals to those less fortunate, living on the streets of Metropolitan Atlanta. During this time, all of the funding for these Feedings has come out of the volunteers' pockets or from donations from churches and other individuals. Late last year, this effort qualified as a 501(c)(3) charitable organization under the name "Feeding the Homeless Project, Inc."

With the 501(c)(3) status a Board of Directors was appointed and plans to help make this effort sustainable and duplicable were put into place.

This simple concept revolves around two trailers equipped with a stainless steel gas grill designed to go where the need is greatest, and prepare and serve hot meals for the Homeless. It is the desire of FTHP to not only serve the less fortunate with a hot meal and a hearty smile, but to bring attention to this ongoing and growing problem and provide volunteers with the opportunity to become directly involved in the cause. Our first step in providing sustainability is to offer Community Service events to companies or groups interested in participating in this effort. It is our intention to duplicate what FTHP has been doing for the last few years for individual organizations.

You are invited to join our effort by sponsoring a Community Service event organized and run by FTHP for your organization. While we will still seek and accept donations outside of our sponsorship program, we believe the support from this program will provide a foundation of resources that will allow FTHP to acquire additional trailers and serve the community in multiple locations at the same time and thereby increase the number of monthly Feedings we currently provide. Community Service Event Agreement

This Agreement is entered into between **Feeding the Homeless Project, Inc.** a non-profit organization qualified as tax-exempt under U.S.C.501(c)(3) (hereinafter referred to as the "FTHP"), and _____ (hereinafter referred to as "Sponsor"), in order to provide Sponsor a Community Service Opportunity to Feed the Homeless at locations designated by FTHP within the Metropolitan Atlanta area. Pursuant to the terms and conditions described more particularly below, Sponsor will make a donation to FTHP in the amount of _____ (\$ _____) and supply volunteers to FTHP for the purpose of staffing one or more community service event(s), hereinafter referred to as a "Feeding" at a location chosen by FTHP. All volunteers will be recruited and assembled by Sponsor and supervised and trained for the performance of their functions by FTHP. All volunteers will be persons who, of their own sole and free volition, are desirous of contributing their time and efforts to the aforementioned community service event in the manner provided for in this Agreement. No volunteer made available by the Sponsor for the purposes of this Agreement shall be regarded as an employee of FTHP for any purpose.

Feeding: Is defined as a single event on a Saturday morning where FTHP will meet the Sponsor's volunteers at a predetermined time and location and then take mobile meals to a location determined by FTHP to be where the need is greatest. Mobile meals are meals prepared on site by FTHP and their volunteers using food, equipment and other supplies provided by FTHP (or others) to feed the homeless or less fortunate people in a particular area. A Feeding usually consists of breakfast food and beverages and is served between 6:30 am and 8:00 am on the designated Saturday morning.

Sponsorship Recommended Donations:

Single Month Sponsorship =	\$1,000
Two Months Sponsorship=	\$1,900
Three Months Sponsorship=	\$2,750

Each month of sponsorship pays for one Community Service Opportunity for the Sponsor's company (the Sponsored Feeding), one "Pay it Forward" Feeding (a second Feeding for general volunteers), Sponsor recognition on the FTHP website and PR opportunities with local media outlets. As a 501(c)(3) qualified organization, your sponsorship contribution is tax deductible.

Staffing: Volunteers must be a minimum of 10 years of age (unless accompanied by a parent or guardian) and have a State issued identification, with their date of birth on it, on their person.

Each Feeding will be staffed with a minimum of four (4) qualified volunteers provided by FTHP and a minimum of six (6) but no more than sixteen (16) volunteers provided by the Sponsor. One of the qualified volunteers designated by FTHP shall be the "Feeding Manager," responsible for the activities of the Feeding and the volunteers staffing it.

FTHP reserves the right to cancel a Feeding, or reassign any group or groups provided by the Sponsor, if any group fails to have the required number of volunteers needed for the Feeding.

Reporting times are recommended to be 10 minutes prior to the announced meeting time.

Each group is required to stay until the Feeding chores are completed (cleaning, etc.). Each Feeding Leader will be required to stay until the Feeding has completed all the required clean up.

Photography: Our mission is to prepare and deliver hot meals, toiletries, hats, coats, gloves, etc., to those less fortunate and to raise the awareness of their plight. We strive to treat each person we serve with love, dignity and respect. Our policy on photography of the event is to 'be discrete'; we don't want to violate anyone's self-respect or esteem. Any photography taken on site at a sponsored Feeding shall be the sole property of FTHP and cannot be used for any external promotion in connection with FTHP without the express written permission of the FTHP Board of Directors.

HOLD HARMLESS & RELEASE FORM

1. The person/entity indicated above by signing this Agreement, acknowledges for itself and its officers, directors, shareholders, employees, agents, successors and assigns (the "Participant") that it and (and its officers, directors, shareholders, employees, agents, successors and assigns) is voluntarily participating in an event to feed homeless persons in an event sponsored by FEEDING THE HOMELESS PROJECT, INC. as part of a charitable/civic event (the "Event"). The Participant acknowledges that such events may take place in urban areas and that such voluntary participation can be dangerous in nature and could result in possible injuries or loss of limb or life of the Participant.

2. In consideration of FEEDING THE HOMELESS PROJECT, INC. providing the equipment and food necessary to complete the Event, Participant hereby makes the following representations and warranties to FEEDING THE HOMELESS PROJECT, INC.:

- (a) Participant fully realizes the dangers involved with the Event provided hereunder and Participant **FULLY ASSUMES THE RISKS ASSOCIATED WITH THE PARTICIPATION IN THE EVENT, INCLUDING THE POSSIBILITY OF PHYSICAL INJURY, LOSS OF LIMB OR LIFE, ASSOCIATED WITH THE EVENT.**
- (b) Participant, and for his/her heirs, executors, administrators, legal representatives, officer, directors, shareholders, employees, agents, assignees, and successors in interest (also collectively referred to as the "Participant") does hereby **WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISES TO INDEMNIFY AND NOT SUE** FEEDING THE HOMELESS PROJECT, INC., and its officers, directors, owners, employees, agents, shareholders, successors and assigns (hereinafter collectively "FEEDING THE HOMELESS PROJECT, INC.") **FROM ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION AND OTHER LIABILITIES THAT MAY ARISE IN RELATION TO THE EVENT, INCLUDING WITHOUT LIMITATION, ANY INJURY, LOSS OF LIMB OR LIFE, TO PARTICIPANT, OCCURING DURING THE EVENT.**
- (c) Participant agrees to participate in the Event in a manner that neither endangers itself/himself/herself nor others. Participant assumes responsibility and liability for his/her actions during participation in the Event. Participant acknowledges that he/she has no physical or medical condition which would endanger Participant if Participant was to participate in the Event or that would interfere with Participant's ability to participate in the Event.
- (d) Participant agrees that the above representations are contractually binding and are not mere recitals and that should Participant assert any claim in contravention of this Agreement, the Participant shall be liable for all of the expenses incurred by FEEDING THE HOMELESS PROJECT, INC. in defending any such claim, unless FEEDING THE HOMELESS PROJECT, INC. is adjudged liable for willful and wanton negligence with regard to such claim. Participant agrees that this Agreement may not be modified orally and a waiver of any provisions shall not be construed as a modification of any other provision herein or as a consent to any subsequent modification. Furthermore, every term and provision of this Agreement is intended to be severable. If any one or more of the provisions of this Agreement is found to be unenforceable or invalid, such invalidity shall not affect the enforceability of any other provision hereto. This Agreement shall be governed by the law of the State of Georgia.
